

PRIVACY POLICY - ONCOLOGY ONE

Oncology One Pty Ltd (ACN 125 693 003) (hereafter 'Oncology One', 'we', or 'us') is based in Australia. Our collection, use and storage of personal information is governed by the *Privacy Act 1988* (Cth) including the Australian Privacy Principles. We are committed to protecting the privacy of your personal information and this Privacy Policy outlines our ongoing obligations to you in respect of how we manage your personal information.

'Personal information' means information or an opinion about an identified individual, or an individual who is reasonably identifiable, whether the information or opinion is true or not.

By accessing and continuing to use our website at www.oncologyone.com.au, you consent to us collecting, using and disclosing the personal information that you supply, in accordance with this Privacy Policy.

WHAT INFORMATION WE COLLECT

The type of information that we collect from you will depend on how you use our website and how you interact with us. The personal information that we collect and hold about you may include your full name, email address, and your website usage information such as the date and time of your visit, IP address and pages you have requested.

HOW WE COLLECT YOUR INFORMATION

We may collect your personal information whenever you input such information into our website.

We also use cookies, which are small data files that are transferred to your computer by a website or its service provider. Cookies capture and remember certain information regarding your use of the website. It is not possible to identify you personally from our use of cookies. We use cookies to help us track your website usage and help us customise your website experience.

Most web browsers automatically accept cookies but you can choose to disable cookies through your internet browser settings. However, our website may not operate as intended for you if you do so.

In addition, we also use Google Analytics, which is a web analytics service that tracks traffic information about the visitors to our website. Google Analytics does not collect your personal information, identify individual users or associate your IP address with any personal information you may have previously provided to Google. We use reports provided by Google Analytics to help us understand website traffic and usage. You can opt out of Google Analytics by using the Google Analytics Opt Out Browser add on.

PURPOSE OF COLLECTION

We collect, hold, use and disclose your personal information to:

- operate, protect, improve and optimise our business and your website experience;

- maintain contact with parties interested in our business, and keep them informed of new developments, services and opportunities available;
- maintain contact with potential collaborators in research activities;
- comply with our legal obligations.

By joining our mailing list, you consent to the receipt of direct marketing material. We will only use your personal information for this purpose if we have collected such information directly from you, and if it is material of a type which you would reasonably expect to receive from us.

We do not use sensitive personal information in direct marketing activity. Our direct marketing material will include a simple means by which you can request not to receive further communications of this nature.

STORAGE OF INFORMATION

We will store personal information for as long as a subscription is active or as long as needed for the purposes described above.

We take all reasonable precautions to safeguard your personal information from loss, misuse, unauthorised access, theft, modification or disclosure. We also limit access to personal information to our personnel on a need to know basis.

THIRD PARTY DISCLOSURE AND OVERSEAS TRANSFER OF INFORMATION

We may disclose personal information to service providers who assist with managing our website. Other than this, we do not sell or otherwise trade to unrelated third parties the personal information that we collect from our website visitors at any point unless we receive your consent to such disclosure. Your personal information will not be disclosed to recipients outside Australia.

In some circumstances, the European Union *General Data Protection Regulation* (GDPR) provides additional protection to individuals located in Europe. The fact that you may be located in Europe does not on its own entitle you to protection under the GDPR. Our website does not specifically target customers located in the European Union and we do not monitor the behaviour of individuals in the European Union, and accordingly the GDPR does not apply.
